ORDER

According to Rule 21 of Part II (General rules) of General Service Rules of CAPE, seniority of a person in a service, class, category or grade should be determined by the date of the order of the first appointment to such service, class, category or grade. The rule further stipulated that if more than one person is appointed by the same order their interseniority should be in the order given in the appointment order. It has also been specified that if more than one person is appointed on the same date by different orders their inter-se seniority should be as announced by the appointing authority based on the rank list and rules of communal reservation wherever applicable.

- 2) Accordingly provisional seniority list of Librarian Gr.IV in the institutions under CAPE have been published/circulated to the staff members calling for objections/valid corrections, if any vide reference read as 1st paper above. At the time of publishing the same Shri. Usmay Koya P.T, Librarian Gr. IV vide letter read as 2nd paper above has furnished his objection against his seniority. But as per this office letter read as 3rd paper above, it was informed to him that the objection raised by him is not genuine. seniority list of Librarian Gr.IV is finalized and published in the official website of CAPE vide proceedings read as 4th paper above.
- 3) As per the letter read as 5th paper above, Shri. Usman Koya P.T, LIbrarain Gr. IV has again raised objection against his seniority and informed that based on the rotation of rank list his position is just above to Shri. Padmarajan R.M and requested to rectify the same.
