CAPE-Estt -Promotion Granted to Trade Instructor Grade-II (Electrical) as Trade Instructor Grade-I ((Electrical) in the scale of pay of Rs.27800-59400 - Orders issued -

As per the paper read as 1<sup>st</sup> above, it has been ordered that the Trade Instructor Grade-II after successful declaration of Probation shall be promoted as Trade Instructor Grade-I in the scale of pay of Rs.14620-25280 (PR) against vacancy.
